nother election is banging the door. We will not be preparing to vote for Governor in 2023 but we are going to have other elections: House of Assembly, House of Representatives and Senate.

As a community newspaper, it is our responsibility to showcase and interrogate those who are striking to represent you in the foregoing legislative houses. In this edition, we showcase the leading aspirants seeking the tickets of the two leading political parties — the All Progressive Congress (APC) and People's Democratic Party (PDP).

This first step is very critical because no matter how good your choice is, if a popular party does not present him or her, there is no way you can vote for such a person next year in the elections proper. Yes,, it is now possible to run as independent candidate but you and I know that it will take some time before independent candidates are able to win elections.

Unfortunately, you and I cannot participate in this first stage of party primaries. In fact, not all card-carrying members of the parties are going to be involved. Instead, the party leaders are seeded to vote in the "delegates" election to pick the flag bearers.

Before, such tickets are determined by incumbent state governors and party chieftains. Now, the trends are changing as political party leaders are becoming more politically literate and are less-inclined to give away their votes for the highest bidder.

It does not really make sense to give someone your ticket because he has bribed you. He then goes on to make hundreds of millions of naira at your expense. You make him and he gets there and refuses to make you. It's been the same story for several years when some elected representatives get into office and disappeared until another four years when the need

revalidation of the ticket to contest again.

Thus, party leaders are now more stringent. In the past, communities used to go and beg people to come and contest to serve. This was the way the likes of Olu Akinfosile, Kayode Iwakun, Olu Atiroko, MAE Onukun, Abiodun Ijose were called to serve. In those days only those who have te spirit of service got their names on the ballots. Now, things have changed. The influence of money is paramount. So also is the influence of "political anointing" a euphemism for "candidate imposition".

The party leaders need to know that heavy responsibility is on their shoulders. We wrongly assume that it is just legislative house, they cannot do anything meaningful for the people. How wrong that assumption is. There are lawmakers in this country who have completely positively turned around the lives of their constituents. What are we saying? Was the late Chief Olu Akiinfosile not elected into the Federal Parliament where he shone like a million stars, delivering dividends of democracy for his people? Even people who served later like Senator Yele Omogunwa, Senator Bolu Kunlere, Hon Mike Omogbehin etc. all executed one constituency project or the other.

It has been the culture that lawmakers do constituency and empowerment projects although such are not their primary areas of duties. Which useless laws are they going to make in the face of hard-hitting poverty in the land?

The delegates of the primaries must pick the people that genuinely have Ikale society and its people at heart in these primaries. If they do their own part of the bargain, then the electorate would easily pick from the two in the general elections next year. In that situation, head or tail, Ikale wins. But when we allow money to be the overriding interest or allow some powers from Abuja or Akure to dictate who we shall give party ticket, we

are actually acting very stupid. That should not be part of our character as Ikale people.

The profiles of those seeking tickets this year are intimidating. All of them are very qualified. The problem is that not all of them have historically shown any commitment to serve the people. We should not elect people who want others to serve them.

Essay and Quiz Competitions: What is happening?

As a way of promoting education and learning among the younger ones, the management of Ikale News instituted two projects, Asiwaju Benson Akindeju Essay Competition & Oladapo Fadeni Quiz Competition. The former is to be competed for among Igbotako indigenes who are undergraduates while the latter is for all secondary schools in Irele and Okitipupa LGAs

And so they should also know that South Africa is the organic Number One country in Africa because they have the best eight universities in all global ratings in Africa. Reforming the Ikale Central Organization (ICO)

n the April edition of *Ikale News*, our lead story centred on Ikale leadership and direction (lack of it). You can download free copy by going to **ikalenews.com**. In that edition, we highlighted the challenges and implications of Ikale community not having visible leadership and I did promise to propose how Ikale Central Organization (ICO) may be restructured and reformed. Here I am, fulfilling that promise.

Background of the defunct ICO

For many decades, Ikale people have not lacked leadership. Every town has king, bale or high chief that administers the community as the case may be. I remember as a kid in Igbotako that after the passage of Oba D.I. Juba as Rebuja we did not have a king in Osooro for many years. During this time, various high chiefs administered law and order in their quarters. There was no vacuum until we had the Rebuja in 1978. It was the same in all towns and even villages.

Another level of leadership was the towns union. Every town had unions. We have the Irele Progressive Union, Igbotako Progressive Society, etc. Membership is voluntary, not democratically constituted. That is, once your father or mother is from the town, you (male or female) can join the meetings. The meetings had corresponding chapters in major cities across Nigeria.

In Lagos, there was an Ikale Development Union (IDU) because Lagos served as our melting pot. So, two members of the various towns unions are nominated as their representatives at IDU. Some Unions put a time frame to the years their reps would serve while some did not. So, some were like permanent representatives at IDU.

What did they do at IDU in those days? Nothing much beyond eating cool pounded yam and obeta. Occassionally they discussed some challenges at home but it was more of a cultural thing. In the early 2000, alongside some Ikales like Dr. Paul Akintelure, Tunde Ayenumelo and Deacon Goke Owamoboye, we formed Ikale Vanguard as a pressure group to bring development to our Ikaleland. We now approached IDU that the Union needed to be doing more. The Babas gladly welcomed our initiative. They said they had been praying for those who would take over from them and inject new ideas. This led to a fantastic Ikale Day in Lagos. From then on, IDU had been doing well but I can assure you that it is not at its best today.

Alongside IDU was the ICO. The ICO also had representatives from each town and then the Obas. But it was more of an elite thing. The ICO was to be our own "Afenifere" in

Ikaleland; above partisanship and serving as pressure group to bring development to Ikaleland. Past leaders included the legendary Pa Adegborioye, Pa Akinfosile, Dr. Abiodun Ijose and Dr. Amos Akingba. The ICO was able to resolve so many lingering crises, especially amongst communities. I think when Chief Kayode Iwakun led the group, partisan politics inevitable crept into ICO and it nailed its coffin till today. The late Iwakun, as you know was a consummate politician.

Why we need a new ICO


The following are the simple reasons we need ICO:

- 1. We need to forge a united front in Ikale, devoid of town or clan sentiments, in order to progress rapidly. Lack of unity has cost us so much
- 2. We need to coordinate our development as a people. Politicians and elected representatives need to be engaged from time to time to bring dividends of democracy to the land. We need to get our priorities right in this regard. What do we need most or now and in which order as a people?
- 3. We need to document our history and culture. There is need for an organization that can serve as the repository of our tradition and culture, keeping archives of very important or iconic features of our tribe.
- 4. we need an appellate socio-cultural organization to resolve disputes amongst us as a people or communities and between our community and other communities and organizations.

What I propose

Based on the foregoing, I propose as follows:

- 1. Ikale Central Organization should be registered with the Corporate Affairs Commission, Abuja as a limited by guarantee or non-governmental organization with the aforementioned objectives
- 2. Membership of the body shall be as follows;
- i) The Oba of every town shall appoint a representative to ICO every year
- ii) Every Town Union shall ELECT a representative to ICO every year
- iii) The President of National Union of Ikale Students shall be automatic member of ICO for the duration of his or her tenure
- iv) All social clubs in Ikaleland, at home and in the Diaspora (registered with CAC) shall ELECT two representatives every two years to serve on ICO
- v) All titled chiefs in Ikale shall ELECT one person to represent the body at the ICO
- vi) Past president of ICO shall be automatic ex-officio member of ICO for life
- vii) All Ikale professionals and academics



(through the League of Ikale Professionals and Academics to be registered with the CAC) shall have their president as member of ICO for the duration of his tenure as the League's president.

- viii) President of Ikale World Congress shall be member of ICO for the duration of his or her presidency.
- 3. The above members shall constitute their EXCO President, Vice President, Treasurer etc.
- 4. Registered members of political parties are disqualified from membership of the ICO. The Organization shall be non-partisan and non-political.
- 5. The leadership of the ICO shall develop strategies for funding its programmes but foundation funds shall come through annual dues of members and donations from Ikale people across the world.

I came up with the aforementioned ideas also as a way of priming up other important bodies that can develop our various towns. For instance, some towns do not have effective towns unions any more. Some, the town unions only organize cultural day and eat pupuru and obeta; finish. No scholarships, to repair of roads, not even sign posts...nothing!

Then the idea of having Association of Ikale Social Clubs. We need as many of these clubs in each town as possible (registered associations), so that they can be hands of God in their towns to develop the towns and help people. The professionals need to come together and so think of how our roots can develop. There used to be Okitipupa Business School. It is dead now. We need these bodies and then have them at the apex ICO. All our Obas would be patrons to ICO.

So when our President says it wants to pay a visit to the Governor, the governor knows the entire Ikale is coming. If important politicians or Nigeria's president is coming to anywhere in Ikale, the ICO leadership must be represented. Etc. etc.

I want all Ikale sons and daughters to interrogate this suggestions. I will then organize a workshop via zoom where we can take final decisions and go on to register ICO. Then we can go full blast to reconstitute ICO and start running to develop our community and its people.

God does not make mistakes. He chose to bring us to this world via Ikale. And I am personally proud of that. Let us all do the much we can before we go. We should not leave Ikale worse than we met it. Ikale used to be better than what it is now. We must act, very fast.

APC: The New PDP in Town

he National Convention of the ruling All Progressives Congress (APC) may have come and gone, but the echoes from the convention which took place at the nation's capital, Abuja, on March 26, after a prolonged crisis rocking the party, continue to reverberate across the length and breadth of the country generating different and differing interpretations.

For me, one major takeaway from the new leadership of the party is that the Peoples Democratic Party has found a way to transmute itself into the core DNA of the APC, a coalition of disparate parties that came into existence in 2013 to challenge the then ruling PDP for power in the 2015 general elections. In short, the APC is PDP and the PDP is APC.

In any social-cultural and political organization, the two most important portfolios are those of the chairman and secretary of the organization respectively. The two principal officers are the ones who determine what happens in the organization and manage its day-to-day affairs. Therefore, the duo can be said to be the oxygen powering the organization.

In the recent composition of the National Working Committee of the PDP, which came as a result of its national convention, two former top shots of the PDP were elected via consensus as the national chairman and national secretary of the APC respectively. I refer to the duo of Senator Abdullahi Adamu, who is now the national chairman and Otunba Iyiola Omisore, national secretary, of the party.

In case you don't know, Adamu, a serving senator, remains a founding father of the PDP and governed Nasarawa State on the platform of the party for two consecutive terms of eight years before moving to the APC in 2014. If there was anyone who exemplified the essence of the PDP then, it was Adamu because of his loyalty to the party and then President Olusegun Obasanjo. He was elected to the senate in 2011 on the platform of the PDP and had previously served as the Secretary of the Board of Trustees of the PDP!

Although, while Chief Omisore started with the Alliance for Democracy(AD) where he served as the Deputy Governor of Osun State between 1999 and 2002, he rose to national prominence on the platform of the PDP where he won election into the senate in 2003 while in prison for being allegedly involved in the murder of Bola Ige, who was the attorney-general of the federation and minister of justice as of the time of his gruesome murder.

As a senator on the platform of the PDP, he also won his re-election in 2007 and headed the all-powerful senate committee on appropriations till 2011 when he felt it was time to become the governor of Osun State, an attempt he made a couple of times but failed to actualise. He was said to have played a pivotal role in the supplementary election that brought Governor Gboyega Oyetola to power in the 2018 governorship poll in the state. His crucial support for the party as of that time is said to have signalled his entry into the APC, a move that culminated in his election as the

national secretary of the ruling party.

Besides senators Adamu and Omisore, there are other prominent members of the new APC NWC who were staunch stalwarts of the PDP in the past. As recent as late 2021, the new National Women Leader of the APC, Dr Betta Edu, was of the PDP and a harsh critic of the Buhari-led administration. She defected to the APC when her principal and benefactor, Governor Ben Ayade, moved to the APC.

Her indication to vie for the position of National Women Leader of the APC generated a horde of angry reactions, especially from APC partisans online. Despite the condemnations that trailed her indication to vie for the position, she was still elected as the NWL of the party! Minister Rotimi Amaechi's protege, Victor Giadom, is also the National Vice Chairman of the APC representing the south-south. He was an influential PDP honcho in the past.


Expectedly, the election of these former PDP henchmen into the highest leadership cadre of the APC has been generating angry reactions from core APC supporters who feel that the positions should have been reserved for those who have been with the party since the day of its formation. While their argument is valid, it's not, however, sacrosanct and therefore not binding on the super stakeholders of the party who determine who gets what, how and when within the party.

One other significant lesson from the convention which was more like ratification of consensus done at the zonal level is that for you to amount to anything significant politically in the Nigerian political firmament, you must have some influential backers who can pull strings for you otherwise, your aspiration is dead on arrival, no matter how good your intentions are or the alpha credentials you parade.

On the ideological plane, with the recent reconfiguration of the APC leadership, which saw many ex-PDP strong men holding sensitive positions in the party, it can be argued with convincing examples that the APC has become the PDP in character and content. This implies that it's even intellectual fraud for the APC to parade itself as a 'progressive' party when in essence, the current cornerstones of the party, were once the building blocks of the PDP.

In a way, the PDP is APC and the APC is PDP. The more things appear to change, the more they remain the same. It's a political mirage that is consistent with the sort of politics played in a bogus democratic setting where the politicians are devoid of any principle and belief and the parties are built without a binding ideology. Politicians in this clime see political parties as just special-purpose utility vehicles to actualize their ambitions. Which explains why defection and cross carpeting are recurring decimals in our body polity.

I am pro-zoning



politicians will always like to shift the goal post in the middle of a match to suit their aspirations.

It's for the above reason that some politicians, knowing that the arrangement does not favour them, have been canvassing the abrogation of zoning in our polity right from the local level up to the national level.

In a heterogeneous society like ours, and with our democracy still evolving, I find it plausible and reasonable to support the zoning of political offices and even political appointments.

First off, zoning will encourage the inclusion of other tribes and zones who may be cheated out in the contest for power because of their disadvantaged numerical strength by those who have the advantage of numbers. Therefore, zoning of positions will discourage tyranny of the majority and also help minimize group dominion.

The argument by anti-zoning crusaders that zoning encourages incompetence and promotes the entitled is fallacious and untenable. I have argued several times in a lot of my writings that there's no zone or tribe in this country where there are no competent men and women who can hold their own in governance and leadership positions in the country if allowed to serve.

I contend that when a position is micro-zoned to a particular tribe, district, zone or ward, the best can always be elected from such a place because more qualified candidates will come out to vie for the available elective offices.

In a country fraught with pernicious ethnic agitations, it's dangerous to intentionally exclude some tribes and zones from the leadership space because they do not have the electoral numbers to win them such offices in a contest. It's an invitation to rebellion and chaos whose end-products are better imagined than experienced. You can't hold a people down for too long; something is bound to give way eventually and when that happens, I hope the consequences will not be disastrous.

In totalizing this short intervention, as we prepare for the 2023 general elections, I enjoin all political operators to find a way to give political accommodation to fringe groups, tribes and zones in the various elective offices being sought. That way, there'll be inclusion and cohesion which will help, at least, to keep the fabrics of the country together.

Political Party Primaries: Know the top Contenders

The race for the State House of Assembly and National Assembly is reaching a crescendo this month with the screening and primaries of contenders in the two leading political parties in Nigeria, the All Progressive Congress (APC) and the People's Democratic Party(PDP). We serve you the profiles of the top contenders:



Matthew Oye Oyerinmade aka **MATO**

athew Oye Oyerinmade, popularly called 'MATO' began his political career as a student leader. His election as a representative of his department in the students' representative council of the then Ondo State University now Ekiti State University Ado-Ekiti and subsequently as the speaker, "first among equal" at the peak of the Military incaution into Nigeria Politics and the agitation of Nigerian Students for a Democratic Order, placed him in the front burner of agitation for a Democratic rule and one of those who championed the course against obnoxious and draconian policy of the then Military Government in 1992 for a reduction in school fees of Primary and Secondary Students in Ondo

Nigerian Politics Coalesce around two political traditions deriving from the country's pre and post independent periods, the progressive and the conservative. This was visibly exemplified with the creation of two major political parties, SDP and NRC by the military under which 1993 election

was held.

MATO was deeply imbued in the Awoist tradition, having exposed to its principles and leading actors from the young age. Born in May 27 1967 in Oke-Igbo, a major town in Ile-Oluji-Okeigbo Local Government Area of Ondo State. He is the youngest of 12 children.

As his name signifies OYERINMADE, MATO could claim royal Okeigbo lineage, his father was High Chief Agoro of Okeigbo Kingdom and his mother was a business mogul in cash crop of lolanut in the Western region and beyond. MATO was brought up by his parents, and they, like many Yoruba people were delighted by Awolowo's vision of a United Nigeria, economically vibrant nation and so, promoted the ideals of socialist and parliamentary Democracy.

After his primary education at St. John's Primary School, Okeigbo and having excelled academically and in sport, MATO graduated from Oloroke Grammer School Okeigbo with O'Level Certificate. He was admitted into Ondo State University between 1990 and 1995 where he graduated with B. Ed Hons in Social Studies.

This provided an opportunity for him to meet other progressive minds which to greater extend, broaden his political horizon. He is chairman/owner of numerous business outfits such as NICON Insurance, Energy Bank (Ghana), NICON Luxury Hotels, Global Fleet Oil & Gas, Nigeria Reinsurance Corporation and NICON Properties.

Ibrahim began his foray into politics in 2003 when he contested for the governor of Ondo State under the platform of the All Nigeria People's Party (ANPP). He came third in the election behind winner, Dr. Olusegun Agagu and incumbent Gov Ade Adefarati.

He fizzled out of politics until 2015 when he contested the primaries of the ticket of the PDP against Mr. Eyitayo Jegede and won the ticket via court ruling. His win was reversed just few days to the election and Jegede, who flew the PDP flag, lost to the current incumbent, Arakunrin Rotimi Akeredolu.

He was local government councilor, and chairman and later member House of Representatives for Ilaje Ese Odo Federal Constituency from 2011-2015. At the national assembly, he was chairman a House Committee on Niger Delta.

Agbo attended Community High School in Kiribo Town and later moved to Methodist High School in Okitipupa LGA. He then went on to study Law degree at **Igbinedion** University, Okada in Edo State and graduated with Bachelor of Law (LL.B) at 2nd Class Upper division; and subsequently received his <u>Call to the bar</u> in 2010 after graduating from the Nigerian Law School in Abuja.

A thorough-bred, grassroots politician he joined Zenith Labour Party after losing the PDP gubernatorial primaries to Eyitayo Jegede. He was the 2020 gubernatorial candidate of Ondo State in Zenith Labour Party led by former governor Olusegun Mimiko. to Chief Newton Ajayi and Mrs Rebecca Ogunjinte (née Olubusade). he hails from Kiribo Town of Western Apoi tribe in the Ese Odo 'Local Government Area' (LGA) of Ondo State.

He contested the October 2020 Governorship election in Ondo under the Lanour party and lost. with Gboye Adegbenro as his running mate. Agbo is contesting for Senate ticket under the platform of the People's Democratic Party.



NICHOLAS OLUBUKOLA **TOFOMOWO**

ofowomo Nicholas Olubukola is the Incumbent Senator Representing Ondo South. He contested under and won the seat on the platform PDP. He is seeking a second term in the Senate.

A native of Ile-Oluji in Ile-Oluji Okeigbo Local Government Area of Ondo State, Tofowomo is a former commissioner of Transport in Ondo State.

His outstanding performance as commissioner in Ondo State (under the Olusegun Mimiko Administration) is believed to have helped in shaping his political career positively. As a commissioner, for example, he initiated the Free Shuttle Buses across 18 LGAs of Ondo State to assist Parents reduced the cost of taking their children to school; he introduced and initiated a bill for the creation of Ondo State Traffic Management Agency which was meant to reduce the level of unemployment in Ondo State.

He initiated and submitted a master plan to the Federal Government for the creation of Alape Sea Port in the riverine area under Ilaje LGA of Ondo State and this was approved by the Federal Government before the end of his tenure as commissioner for Transport. This Project which is still in the pipeline till today was officially handed over to the APC- led Administration in Ondo State for follow up towards implementation. However, our findings have shown that ever since Tofowomo left, there is no one following up with the Federal Government. If elected as our next Senator in Ondo South, he will definitely see to the implementation of this project.


He also initiated the installation of Traffic Lights and Bus Stops in Akure metropolis and transformed the office of the Vehicle Inspection Officers (VIO) under the Ministry of Transport by increasing their IGR from less down 250 thousand Naira only in a month to 1.5m in a month to support the state IGR. It shows that Otunba Nicholas Tofowomo can turn a desert land to a land of Milk and Honey.

Senator Tofowomo is not new to primaries. The last primaries that earned him the ticket of the party in October 2018 was intense, having polled 241 votes with Engr. Ademulegun polling 227 votes and the former Commissioner for Environment, Sola Ebiseni polled 177 votes at the primary election. In the supplementary election that followed be beat incumbent Senator he was able to beat incumbent Senator Yele Omogunwa because certain political leaders ganged up against Omogunwa in Irele in the last minutes of election. Omogunwa scored 51,993 while Tofowomo scored 79,036 votes.

His performance in the Senate is seen by political pundits as weak. The major headline he has hit so far was when he appointed 46 aides on July 24, 2019. Although he has explained his efforts at restoring electricity to Ondo South, much of the Senatorial District has been in perpetual darkness.

But the Senator has the financial muscle to give a good showing at the primaries.

He established Arowolo Oil and Gas Ltd in 2014. Due to his entrepreneurial skills, the company grew in leaps. The company markets petroleum products across Nigeria with over 19 retail outlets. The Group is also into logistics services and agric trading. Recently,, it veered into hotel and hospitality.

Jimi set up the Arowolo Royal foundation as a non-for-profit organization to extend hand of fellowship of the less privileged in the society .when a man has been blessed by God and his ready to share his blessing with his people, he has such a strong feelings for humanity that promotes the spirit of his philanthropist per excellence.

He joined partisan politics few years ago, pitching his tent with the APC, under which platform he is seeking the House of Representatives ticket. He is gradually pulling his weight in the party as he was able to install his elder brother as the chairman of Irele Local Government. The understanding that Irele LGA should produce the next Rep member for Okitipupa/Irele Federal Constituency favours him in his party but he was grassroots bulldozer, Chief Toye Albert (SOT) to contend with. Albert was twotime local government chairman of Irele local government and served a term in the House of Representatives.

ormer member of the house of representative from Okitipupa/Irele Federal Constituency, is seeking a return to the House under the All Progressive Congress (APC). As the time of going to the press, he has not bought his form but political watchers predict that he would certainly join the race.

Popularly known as SOT, Toye Albert was chairman caretaker committee of Irele Local Government and later served as elected chairman of the same council. He was later elected to represent the constituency after the tenure Dr. Wole Olakunde. The grassroot politician was beaten to ticket by Osooro Prince, Mike Omogbehin who represented the area under the People's Democratic Party from 2015-2019.

Against the backdrop of comments that he did not perform well when he served in Abuja, SOT claims contrary is the case. According to him. The long list of his achievements includes:

- Advocacy for the construction of Agadagba, Ujosun, Akotogbo and Iyansan road with 500m bridge constructed via Edo state which is still ongoing as at the time of this report. The project is over 60b naira according to Akintoye.
- Advocacy for the Construction of Omi township road through government agency (NDDC).
- Construction of 4 class rooms at Akotogbo in Irele Local government of Ondo State.
- Advocacy for the Ecological project that

- took place in Irele/Okitipupa Federal Constituency between 2012-2015.
- Construction of 4 class rooms in Methodist High school, Irele, Ondo State with electrification and other office facilities
- Ongoing Construction of Skill acquisition center at Ajagba along Igbotu road with parameter fence, in Irele LGA of Ondo State. Project is still ongoing as at the time of this report according to Akintoye.
- Giving Scholarship to 50 students under Okitipupa and Irele Local Governments through the Federal Government Amnesty Program to study degrees and master degrees of their choices in Nigeria and abroad.
- I personally sent 4 students to Malaysia and paid their fees and welfare package for four years (3 doing first degree and 1 masters) before the end of my tenure in office, 2 from Irele and 2 from Okitipupa LGA
- —Getting Employment for 30 constituents in Naval, Police, Civil Defence, and Nigerian custom.
- Reopening of Omi Grammar school with construction of 6 class room block
- I initiated the donation of a giant transformer to Ode Aye community with lightening of the major streets with solar street lights erected through NDDC.
- Over 250 motor cycles distributed to empower peoples across Irele / Okitipupa Federal constituency
- Motion for the construction of a fly over bridge in Ore town, Ondo State
- Motion for the enhancement of the fundamental human rights in Nigeria.
- Four other motions were also moved with one bill sponsored according to Akintoye.

Political watchers believe the contest between SOT and Odimayo would be tough as Odimayo was the "Irele" advantage – that is Irele people, having conceded the ticket to him years ago, would not want to concede the ticket to Akotogbo where SOT comes from. Thus is because the House of Rep ticket is rotated between Okitipupa and Irele LGAs. If Irele town which controls over 75 per cent of

the votes in the LGA picks SOT, it means it has to wait for another eight years to have its own son or daughter to occupy the seat. SOT is seeking the APC ticket in this primaries.

He also bagged Bachelor of Laws (LLB) with SecondClass, Upper Division from Adekunle Ajasin University, from 2007-2011

Sheba is an experienced politician having been in the political system for over 23 years. He contested the SDP primaries in 1992 to represent Irele Federal Constituency in the House of Reps. Though he lost the election then but he remained focus and resolute to liberate our people from the clutches of bad representation. He contested and won the same election in 1997/1998 under UNCP but with Okitipupa L.G combined to form Okitipupa/ Irele federal Constituency. 

Due to a sterling performance in primary school, she was encouraged to sit for the common entrance examinations from Primary three (3) which she passed in flying colours and proceeded to Word of Faith Group of Schools in Area 1 Abuja . While in High school, she continued on the path of hard-work and diligence.

As such, she was made the library

programme for Niger Delta Students. An initiative of the Presidential Amnesty Programme under the leadership of Hon Kingsley K. Kuku and was sent to the USA to study Medicine and Surgery. This required her to first complete a first degree in a relevant discipline prior to medical school.

This means that someone can also have bad character — such as disloyalty, rudeness, hooliganism, pride,, etc.

Let me touch some of these good characters that you will find very valuable as you grow up in life.

The Oriki Of Ikale Clans / Towns And Their Meanings Part One

riki' (praise chant) is a very important part of Yoruba culture. Therefore. Ikale, a major subset of the Yoruba race cannot be an exception.

Oriki varies from tribe to tribe even amongst Yoruba. Some Oriki have negative implications because they have idol worship origins hence some bornagain Christians do not like people to call them by or chant their orikis. For Instance, an Oriki (not of Ikale) eulogises somebody a s "the person that uses a small sword to behead his inlaw (eni ii o nji ida penpe he ana re lori). This is just to show that he is a brave person, but some people see at as negative: How can you praise someone for committing murder, more so to his own inlaw of at people on earth?

Nonetheless, there is hardly anyone why does not feel on top of the world when his or her *oriki* is being chanted. I remember when I was a little boy Ikale.

Said Dr. Bolu John Folayan, a journalist," "Every time I had to go from my father's house to my maternal grandmother's house, I would pass through Mama Ogunje's house and she never failed for once in numerous years to recount my *oriki*. Till today, I love the woman so much because of that those days, anytime I was going to the garage, I ensured I passed through the woman's compoun because he would surely recite my *Oriki* on father and mother side.

"It was not only me. The woman knew the *Oriki* of virtually eve Ikale race and she would just give you your own" he said.

The same thing Chief (Mrs.) Sahaina

The same thing. Chief (Mrs.) Sahaina Owate, my mother. She would not only recount my father's side *Oriki*, she would go on to through her own as an Erekiti Luwoye daughter. I always felt on top of the world. This was mainly because I understood the meanings of what she was saying.

Those who reject *Oriki* do so mainly because they do not investigate the meanings. I agree, that there could be some

Oriki that have negative connotations. It is when we investigate that we can know the bad aspects and take on the good aspects. Certainly, we should not just wish away our Oriki. I have found that most Ikale Oriki are very okay and there is nothing ungodly about them may be because we have a long history of Christianity in our place. Oriki is a reliable source of history and tradition. Wives of Ikale (who may not be Ikale indigenes) usually are skilled in knowing the Oriki. Of course they know how valuable that skill is. For instance, whenever their husbands are not happy or are annoyed, they simply recite the Oriki, and he would be fine with them.

Ondo and Owo indigenes have their *Oriki*. Although he told *Ikale News* that he does not know much of the general Ikale Oriki, Primate Akintan said Ikale people's famous common Oriki is "Ikale Olugbo ogho, Ol'omi a ji p'eja", which translates "Ikale that has extensive land full of rich resources., one that has fresh water rivers with precious fish". If you look at the physical resources of Ikaleland, you readily agree with this.

The development confirms that Ikale people are indeed product of "Federation" – various clans and towns who form Ikale and their different and distinct Oriki. **Editor's Note**: Readers who know the Oriki of Ikale should please send to us.

As



you will see in this report. unlike some other Yoruba ethnic groups who just manufacture fine *Oriki* for themselves. the *oriki* of Ikale towns/people have correlation with their history and environment.

The *Oriki* of some Ikale clans and towns are still hazy and undocumented. But there are there passed orally over the centuries. If there are inaccuracies in this presentation we invite you to write to update us. We therefore welcome more comments and contributions.

ORIKI IKALE

According to eminent spiritual leader and Ikale historian, the late Primate Raphael Akintan, Ikale as a people have some peculiar Oriki in common, just the way

IJU OKE

Iju Oke town is located in Osooro, two kilometres after Igbotako. Iju Oke represents the Oriki of most Akoko people all over Ikale. Akoko people reside in all parts of Ikaleland. but are very predominant in Osooro Kingdom. Akoko 'kale people migrated mainly from Oba Akoko in Ondo State. They were itenerant hunters and they knew the !kale terrain more than other people because they had been hunting therein although they never settled down permanently. Their Oriki goes:

Akoko lo'ke amugun; 'mode Omu a g'oke mataju uku Oma ba ile o se gwen; Oma onomue bale o se gbii Oma rehinrehin seoo sagha

FEATURE

Oma yi e he'ron nori eru Oma paakala soro B'eru o ku, o ra mue (Meaning/Translation:

'Lo'kelo'ke' refers to how Akokos used to climb mountains hunting. Most parts of Akokoland in Ondo North are hilly and rocky. 'A gun oke maa taju uku (the one that climbs and does not fear of dying as a result) portrays Akoko people's boldness and bravery. They are warriors.

'Oma ye he'ron nori eru' (the one that breaks kernel on the head of a slaves) Some people say this is wickedness, but it only shows that Akokos are powerful and wealthy: they have slaves and they do anything with their slaves Be'ru ba ku. Akoko ra mue, means when a slave dies, the Akoko simply buys another slave

From the *Oriki*.one is able to find out that although Akoko people in Ikale are not of royal lineage (they don't become Obas for the entire community), they actually belonged to the royal institutions from where (Oka. Oba Akoko) they migrated to Ikaleland.

IGBISIN PEOPLE

Ighisin people reside on the area between Ilutitun. Ikoya and Mahintedo on the River bank. They pride themselves as the original inhabitant of Ikale, even before the Abodi Olura ajobaju one ghoriye
Olugo apa Alabodi Ukan
Ejo weru were wo no'de udejugho
Ejo lu pa. Oma lele bi beere ni Igbisin
Afenju Oloja e ye L'e bi neni o
Ogwa Jojo ma ma Kiriwo
Olura mekon, Ajobaje Abejoye.

Explanation: Kiriwo is the material used in Ogwa (Congress) that needs to be protected. Once it is beaten by rain or sun it loses its effectiveness. 'One Oja' in most Ikale Oriki talks about somebody that is popular. Oja is like the parliament. It also means literally the market. If all roads are blocked, the road to the market cannot be blocked. If it is ever blocked, there has to be a way for the king to get there. This poem eulogizes Igbisin people as people who belong to a large, one family and whose king is eminent and exposed.

IKOYA

Generally regarded in most Ikale mythology as the 'source', Ikoya is the seat of the paramount ruler of Ikaleland, i.e. Abodi. The Abodi is the most senior Oba in Ikaleland (the first beaded crowned Oba and the prime first-class Oba). Most Ikoya *oriki* is therefore proudly woven around the kingship. Virtually all quarters in Ikoya belong to the royal lineage.

Abodi A baaye, uku a pa ma han Omafifun nene bi si ude Oma bolojo bi ori



came from the Far West. Olori Omowuni Adetayo Olatuyi (wife of the Olura of Ighisinland recited the Ighisin Oriki for us:

Oligbisin Lipepe, Olu Oja One oja konadi ji rere konagho Oma ailere hengwa berogho Abaaye Ogun Olugbada Oma 'Konya de, A dara bi opa iban A ko mi dan weere sele Oma lele bi beere non Ukonya Oma lugboobi Oma Ahenron n'rori eru Bi eru ba leku,jii ku Oma logho topa

Oriki Ikale

Oyinbo Oma kon bode nibo oghoje ti ho, ji'e ri Ogho ka.

Meaning: 'Uku a pa maahan' (one that kills and doesn't have to replace) is also an Oriki of the Rebuja royal dynasty. When I noticed the similarity of this Oriki and Akoko's oriki, 1 asked an elderly woman to explain the connection and she said though Akoko had roots from the Abodi (may be his mother) and that some of the *Oriki* actually cross borders. While in Ikoya when their slaves died. they usually died for nothing (bi eru ba le ku jii ku). But for Akokos, they can would gladly replace. This confirms that keeping slaves was common in those days. Thus, Oriki helps to know the history of a people that were not passed down in writing. "Oma lugboobi' gives us the vocation of the Ikoya forefathers they had extensive kolanut farms. "Ahenron n'ori eru" means the same as that of Akoko and it confirms the fact monarchical powers that past Abodi exercised. They not only had slaves, they did with their slaves were unquestionable.

ERINJE

Erinje people share borders with Ikoya, Ayeka. Okunmo, Oloto and Ilaje Riverine areas. Oral history say they migrated from Ile Ife and their Oriki is woven around the bravery of their early ancestors who went through persecution and wars. Erinje people are essentially warriors. Their *Oriki* goes thus:

Aluma gidi, Aluma Ludari
Oma amu opan je epo ni Ode elu
Jii erira w ma yi wawo
Otun bolobolo ji Oghori maa woo
Ogbori yi woo ba ku de
B' aghoro a muje
One oja e fun orun kole
Ji Ogbori ma ri owo wa
One ja e fo manunu, ji Ogbori ma ri eyin wa
Oneja ye gwa bulebule ji Ogbori maa ma.
Meaning:

As pointed out earlier, this Oriki stresses the bond amongst Erinje people. Ogbori is someone who is not a bonfide member of a group. Erinje people pride themselves as very neat people such that when they eat. They eat on the pavestone so that the food on the plate would not smear their hands (a mu opan je epo... ji eriri awo maa vi wa wo).

ERIKITI-LUWOVE

This historic town after 1gbotako on the Akinfosile road has the following Oriki rendered to *Ikale News* by Chief (Mrs) Ahiodun Aribo. the Alidan of Erekiti Luwoye:

Oriki Ikale

Meaning:

This oriki tells us the origin of Erekiti Luwoye people have their origins from the Lemegha-Norofun-Kosu dynasties their profession farmers and of course that they have handsome men, so much so that beautiful women troop after them. They are very hardworking (aso fifun e jii ole ro 'the lazy person cannot tie a white linen' (because it will be dirty since he will not want to wash it regularly). Etc.

IRELE

lrele is the largest town in Ikaleland and has scores of farmsteds of various clans from the main cosmopolitan settlement, Ode Irele.

Joma lile kaji
Alejo ee gbedo to'be
Eni e bami Oma Luwen-runwen
Ogbori e runwe egungun
Eye e o b'ami
One oja ye lo asofunfun kennekenne

J'e eri ogho ka.

Meaning:

Oma Oja, and Ogbori have the same meaning as previously explained for other parts of Ikale. Irele people have very strong bond of unity. They don't oppose themselves and when you have two or three Irele people in a group, you better watch it: they might always agree and form a clique (.oma tile, ji alejo ee gbedo to ibe) they are landowners that are so proud of being so. They have very extensive land and they also have various tenants. These tenants are called Ogbori or Ogho.

They are also wealthy farmers (**ubo ogho je ti** ... literally. 'where money grows on a tree" (**ji ee ri ogho ka**.) the visitor or stranger dare not touch the money even as they grow on trees. This stresses that Irele people are proud of the extensive resources whose right of authority are vested in indigenes alone. Perhaps no other clan in Irele tribe has more land than Irele Kingdom. Find out and correct me if I am wrong, please. The Oriki also talked about its royal heritage (Olofun) and their neatness and pride - 'one oja' (an eminent person) that wears immaculately white dress.

AYE

You cannot omit the palm tree and the hen in the history of Aye people, who live between Okitipupa and Ore down to Agbabu and other environ but are settled mainly in Ode Aye. Their land ownership extends to the Ore Expressway. In Aye mythology, their ancestors were saved

from being killed by their enemies by hens whose blueprints misdirected the enemies. That's why they don't eat hen. Aye *Oriki* was rendered to *Ikale News* by Chief Adelabu Orina. the I)aniken of Aye Kingdom:

Oma alayelu, oma !aye lope One oja yi ope se mo Oma Halu Jagbo A bo susu mesan ye norigho Alagbogbo Igihoti Onejagba iyee gho eye korin One ja lebi hi eron-ogwa Ji oorun ma pa kiriwo Meaning:

Kiriwo is a chief, high chief (ljama) or Omaja (age grade sons of the soil). The *Oriki* talks about Aye royalty (the ancestors were princes from Ile Ife via Benin. Laye Lope (Ope is Ikale word for palm tree) and the palm tree is very important in Aye economy; they own expansive palm trees farms.

IGBODIGO

This historic town of ikale people are on the watershed on leaving Okitipupa towards Okunmo/Igodan. HRM Oba J. E Ola Aiyeku himself (Obagberume of Igbodigo) gave us the Oriki of Igbodigo people. The late lkale music star. Comfort Omoge was an Olori of a former Oba of the town and she used to recite Igbodigo oriki a lot in her asiko music.

You will notice the similarity at the beginning of the Oriki with that of Iju Oke (akoko); it is a matter of future research... 'Oma gheneghene bi su de' means the Igbodigo son or daughter is as precious and shiny as brass: you don't treat them anyhow. Of course, River Oluwa is central to the economy of the community hence you find it in their Oriki. Igbodigo are always kind to visitors and till today it is one community where in Ikale perhaps where vou find so many visitors (apart from Okitipupa town)... 'Om'Oyinbo miyanje' translates "he taught the Whiteman how to eat pounded yam'. It is said that the Whitemen came to Okitipupa via River Oluwa and met people of Igbodigo who interacted with them. But literally. it means, the person that makes the community homely to the stranger. 'Oma yi o bale j'o se gwen', translates he jumps down and lands firmly', meaning that Igbodigo people are athletic, bold and brave.

IGODAN LISA

The Olori, Eunice Akinsola of Igodan Lisaland rendered the Oriki of Igodan Lisa people. Our university town located on the way to lgbokoda, after Okitipupa is Igodan Lisa. It is a small but very culturally rich community. Their *Oriki* goes thus:

Otna Igodan Lisa aso gbogidi Otna akogbegbe, afori pipa Alugbofin iyi efun hi ekun Ekun amurun golo gbe O gbe Obiren tajo mu ran tanma Tanma gbe ne, obiren ee gbene O pa one sasa bi one pa ido Elehin e kuleje to ghwure

Ara ugba-aya ma ne abese.

Note: 'Tanma' is a kind of cutlass in the palace with a curved head that warrior used in those days to defend themselves during wars. Join us next month for completion of Oriki Igodan
