# WHY SHOULD CHRISTIANS BE AFRAID IN NIGERIA?

"My brother, it is becoming increasingly disconcerting and very curiously so that it is safer to be a Christian in Afghanistan and Pakistan than in Nigeria. It is really concerning...How are you and family faring...?"

That is an excerpt from one of the many messages that I have been receiving from diplomats, family friends in the diaspora since the beginning of the year. I received the above message at the weekend from a prominent and significant family friend who works for an international agency located outside Nigeria. The family friend is apparently frightened by a recent letter (dated June 29, 2022 some U.S senators signed to the U.S Secretary of State, Antony Blinken on the danger Nigerian Christians now live with even as government of the day appears unconcerned about coordinated attacks on Christians.

It is really very sad for me to be writing on my faith when we should be writing contextually on what political leaders who have declared their intention and turn to run Nigeria should be saying and doing at this time. I mean here that at a time when we should be asking what most of the presidential candidates and their party leaders are doing abroad at this time when they should be cashing in on the current wave of get-your-PVC revolution to mobilise voters, we are here commenting on existential threat to Christians in a country that has produced some of the most respected Christian clerics even in global context.

It should be out of my character at this level but Buhari's Nigeria today has made this inevitable because I shouldn't be 'ashamed of the gospel of Christ, for it is the power of God unto salvation to everyone that believeth...'

I have been confessing several times here that I have benefited a great deal from a newspaper business Muslims set up in Abuja some 34 years ago. As I have been saying here, most of the Editors of the newspaper, "Abuja Newsday" (1988-1993) are Christians.

And as I have noted here twice, not many young people are aware of the

reasons I have always been very passionate about Abuja affairs. The nation's capital is actually my second home. My journalism career grew luxuriantly like yam tendrils in the rainy season, thanks to my relationship with the capital about 34 years ago when Alhaji Bukar Zarma, former editor of "New Nigerian" established the first newspaper the "Abuja Newsday" there.

I was pioneer Lagos Bureau Chief from 1988 to 1990 when I was promoted Editor of the newspaper. Abuja is the place my colleagues (bureau chiefs) including the dangerously hardworking Yusuf Ali, the ever-clean Sam Akpe, never-say-die Yomi Odunuga, etc named me "The Dean" of the Bureau Chiefs' 'cabal' while some others outside journalism would call me "The Mayor of Abuja".

There is nothing extraordinary about the sobriquets other than my long-standing experience as a reporter, writer and editor in the 45 years old "capital of the federation". This background is germane to the points at issue today in Abuja where religion & ethnicity have become political tools in the hands of our politicians.

I would like to use this background to trigger some rhetorical questions later about where rains began to beat us as a nation. We are talking about a nation where the bugbear called the national question is threatening the security of the nation again, no thanks to some emerging political mismanagement of the complex federation. In other words, when the newspaper civilization kicked us in the face in Abuja in 1988, there was a good country where religion and ethnicity did not play so much overt role in interpersonal relationships, let alone in recruitments into private and public enterprises. Then Alhaji Bukar Zarma, who hails from Borno state shaped the business plans of publishing the first newspaper in Abuja with Alhaji Hassan Adamu Wakilin Adamawa, from Adamawa state. They are both Muslims. But the

striking element in the story in 1988 in Abuja was that Alhaji Zarma, who advertised for vacancies for journalists in a national daily then did not consider religion and ethnicity when he hired very resourceful journalists from different parts of the country. One thing was clear then: he never asked any candidate's state of origin. And so coincidentally, all the senior editors and most reporters recruited from the North and South were Christians. This is the evidence: Mr. Nick Dazang (Christian from Plateau) was the pioneer Editor; Mr. Jackson Ekwugum (Christian from Delta State) was News Editor, Mr. Dennis Mordi (Christian from Delta State) was Chief Sub Editor; Mr. Samm Audu (Christian from Kaduna State) was Sports Editor; Mr. Skekwogaza Wasah (Christian from Abuja) was Features Editor, Martins Oloja, (Christian from Ondo State) was Lagos Bureau Chief. Other notable names in the newsroom then included Shok Jok, Camillus Eboh, Moji Olaniyan, Moji Olajide, Alex kabba, Emmanuel Obe, etc, all of them Christians. I have written this story several times.

This background shaped the atmosphere that led to the choice of Muslim-Muslim presidential election ticket of 1993, which some desperadoes are artfully referencing today.

It is therefore important for the outgoing president Muhammadu Buhari and his men to note that his (PMB) failure to fulfill his promise and even covenant with the people in the engrafted 'I-belong-to-nobody' words has caused more trouble for the nation he will be leaving in a turmoil on May 29, 2023. The president's governance jet is passing through some areas of turbulence at this moment and what we hear our pilot saying to Christians in the plane is: you have every cause to worry about your safety. There is ever growing perception that 'it is safer to be a Christian in Afghanistan and Pakistan than in Nigeria' at the moment. It is indeed concerning.

A former president once alleged that the Buhari administration has some hidden agenda: Northernisation and Islamisation of the country's polity. That perception has not been erased by actions and colour of appointments in this administration.

That is why it is concerning that even some conflict-sensitive senators in the United States who are also aware of the enormousness of the challenges of managing refugees in Nigeria should there be a political crisis nurtured by religious war, are protesting to the Secretary of State, Antony Blinken at the moment. Only very few commentators on public affairs here are asking why in the face of apparent threat to Christians in Nigeria, even the political class and our representatives in National Assembly are curiously silent.

Specifically, five United State Senators – Josh Hawley, Marco Rubio, Mike Braun, James M. Inhofe and Tom Cotton – have jointly sent a letter to the US Secretary of State, Antony Blinken urging him to immediately re-designate Nigeria as a "Country of Particular Concern" (CPC) under the US International Religious Freedom Act.

They alleged that recent acts of violence targeting Nigerian Christians have underscored the deteriorating state of religious freedom in the country.

In their letter, copied to Honourable Rashad Hussain, Ambassador-at-Large for International Religious Freedom, United States Department of State, the lawmakers stated, "As you are well aware, horrific acts of deadly violence have been committed against Nigerian Christians in recent weeks, including the massacre of churchgoers on Pentecost Sunday and the stoning of a Christian college student. Sadly, such violence has become all too familiar for Christians in Africa's most populous country.

"Last year, however, you inexplicably removed Nigeria's designation as a Country of Particular Concern (CPC) despite no demonstrable improvement in the country's religious freedom conditions. On the contrary, the situation in Nigeria has grown worse. We previously urged you to immediately reverse your misguided decision, and we write today to renew our call.

"Recent high-profile acts of violence underscore the intense religious persecution that is regularly experienced by Nigerian Christians. On Pentecost Sunday, gunmen attacked St. Francis Catholic Church in Nigeria's Ondo state, reportedly killing at least 50 churchgoers. Last month, a violent mob brutally stoned to death Deborah Emmanuel Yakubu, a student at Shehu Shagari College of Education in northwest Nigeria. According to reports, some Islamist students were enraged by a "blasphemous" message Deborah had posted in a WhatsApp group, in which she said that 'Jesus Christ is the greatest. He helped me pass my exams.' Merely expressing one's Christian faith has apparently become tantamount to a death sentence in many parts of Nigeria."

They stated that religious violence and intolerance directed toward Nigerian Christians had worsened in recent years and that one report documented more than 4,650 cases of Nigerian Christians who were killed for their faith in 2021. The lawmakers continued: Accordingly, Nigeria earns the dubious honour—for the second consecutive year—of being the deadliest country on earth for Christians. "We wrote last year that not only has the government of Nigeria failed to take meaningful steps to mitigate such violence, but Nigerian authorities restrict and crack down on religious minorities and detain individuals indefinitely on blasphemyrelated charges. We remain concerned that the Nigerian government is failing to protect the religious freedom and basic safety of its Christian citizens.

"Furthermore, as this year's annual reports from the bipartisan U.S. Commission on International Religious Freedom (USCIRF) and from your own Department make clear, Nigerian government authorities directly participate in the persecution of Christians, Muslims, and even non-theists, most notoriously through arrests and convictions under blasphemy laws. Make no mistake: continued enforcement of statesanctioned blasphemy laws enables the

type of deadly violence that killed

others.

"When we previously wrote you, we were met with a response which failed to answer our questions about why the State Department views Nigeria as not having engaged in or tolerated 'systematic, ongoing, and egregious violations of religious freedom' or even 'severe violations of religious freedom.' This is unacceptable, especially because you are required by federal law to consider the recommendation of USCIRF—which, since 2009, has been to designate Nigeria as a CPC. In fact, USCIRF reiterated in its 2022 Annual Report that it was "appalled" at the removal of Nigeria's CPC designation.

"Despite public statements from you and other State Department officials condemning the recent bloodshed in Nigeria, the fact remains that the Department still does not officially regard Nigeria as a severe violator of religious freedom. "The State Department released its 2021 Report on International Religious Freedom on June 2, which starts the 90day timeline for the Department to make its religious freedom designations. Given the abysmal state of religious freedom in Nigeria, it is incumbent upon you to reverse last year's decision and redesignate the country as a CPC. The moment demands that you do so without delay."

This letter from the United States Senate is a significant reinforcement of the critical factors that have made a Muslim-Muslim ticket at this time a time bomb that can actually win election for a candidate who may thereafter lose the country. This is an avoidable bogeyman Buhari's Nigeria has triggered and that is at the roots of why young Nigerians are suddenly registering to vote so that we can retrieve the pearl we cast before a swine in 2015.

n the third Monday of last month, I saw four missed consecutive calls on my phone. It was the vibrant Ikale activist, Barrister Dele Kuboye desperately trying to reach me.

I was a bit scared — well, let's say I was worried. That was because Dele does not make calls like that. First, he does not call me often. Second, once he calls twice and you don't pick he sends text. Eventually he reached me on WhatsApp with a tacit message, "Doctor, I need to talk to your on an urgent matter o. Kindly reach out to me. I had been calling your other line, no luck".

I called him back the next day, and as usual he went into a long story of how he drew inspiration from me by being committed to Ikale development advocacy. And truly, I recall that he was not only an avid reader and writer for Ikale News when he was in secondary school, he was my Vendor in Erekiti-Luwoye.

Dele went on and on about how Ikale has not been lucky to have good representation at state and national assembly. He did not quite condemn anyone. But he pointed out that they did not do enough. Some, because they did not want to do. Some, because they could not muster the capacity to do more than what they did.

The long and short of his thesis may be surprised in Wande Coal's song "Na Like This We Go Dey Dey?"

Is this how we will be turning out elected people who would do

practically nothing until about four years, when they come back with sacks of money to renew their tenures? And the people would collect money and renew such mandates?

Na like this we go dey dey?

The attitude now is that nobody will go there and do anything to develop the community. They are seen as "all the same. so let us forget the theory of performance". Perfor-kini?



Dele told me he would be running for House of Representatives in 2023. And having known that the PDP and APC primaries had been concluded, I asked him under which party platform he would contest. He proudly said Nigerian Youth Party (NYP). I hope I got the name right. I was so elated.

It was the same theory which propelled us in 2003 to run for elections under a locally unknown party called All People's Party (later All Nigeria People's Party, ANPP). Jimoh Ibrahim went to Abuja to go and bring the party (as we say in local political parlance – o la mu pati wa...). Although we did not win any seat in the parliament and our governorship candidate did not win, we were happy we shook the entire Ondo State. Initially, they did not take us serious. But it got a point we were getting crowd in droves, in thousands...

#### How did we do it?

We offered a "third alternative", also called The Third Force. It is the same thing Peter Obi is trying to do currently. It was what brought Accord



Party to prominence in Oyo State. So those who could not get PDP and AD ticket ran to us and we handed them tickets. The greatest achievement of ANPP those days was that we had proper Ward Executive constituted in the entire Ondo State. In less than two years, we had structure on ground. We hosted the current President Mohammadu Buhari in Ondo State. He slept in Igbotako for three days!

But we were naïve politically. In terms of political strategy and logistics, we scored zero. Even at that, we what we really got wrong was not sustaining our efforts. The bedrock of the party, Jimoh Ibrahim left the party famished and in the lurch. Those who sustained the effort made it big latter. A shining example was Senator Olujimi who went on to be deputy governor and senator.

Let me not digress to much *jare*. Dele Kuboye should sustain his initiative. Anything can happen. Almighty God says whatever he purposes to do would happen. But my counsel to Dele is that if he does not win, he should continue to build this party. I am openly declaring that the next time I am home in Ikale, I will declare my membership for this political party.

This PDP/APC thing is not going to work for our beloved country. We need a party will sound ideology. I was lucky to alive in 1979 when the Unity Party of Nigeria, Nigerian People; Parry (NPP). All the five political parties were: were ideological: National Party f Nigeria (NPN) was republican to the left; United Party of Nigeria. The (UPN) was welfarist. The Nigerian People's

With such arrangement, the voters easily had clear choices. Those more to the right chose NPN. Those who were welfarist chose PRP and NPN. If not for the military that truncated that experiment mindlessly, by now, we would have had a true Workers Party, Green Party etc as it is where we imported the culture of democracy.

Where we often get it wrong is that we want to win now-now. That is very wrong mindset. I am not saying a good candidate cannot win with young unknown parties. Rather, I am saying, it takes time and planning to win.

Again, a young ideological political may not win but can be operated like a pressure group. With their numbers, they seek alliance with the bigger parties! Imagine the Youth Party can boast of just 100,000 voters (sure bankers) for the 2023 election in Ondo State. 
Previous new parties fizzled out because they were operating within the box. Politicians who decamp from PDP to APC and vice versa and "Ojelu" not "Oselu". They are looking for what to eat. From 1979 to 1983, decamping was rare from UPN to NPN and from NPN to UPN. In fact, it was anathema to decamp from a party like Aminu Kano's PRP to NPN. Not only would the leadership not admit people who did not fit in to their folds, the members too would not want to join a party that would make them look like a fish out of water.

The way to grow a new young party is to start small. The elections are becoming fairer and fairer now. So, by the time INEC conducts local government elections, it would seize to be a charade that it has become in the hands of state INECs. Therefore, the young party could start with capturing three Councillorship seats, nine councillorship seats, and ultimately producing the chairman of the local government.

This will give that party opportunity to demonstrate ideas and programmes. Look at what Governor Zulum is doing in Borno. And with that the party launches for Reps or Senate and before you know it, it has become a force to reckon with.

We will look for truly people-centred leaders to contest at that local level. If elections are free and fair, they will win! You don't need all these bales of naira in sacks to do



politics. It is because PDP and APC have boxed us into that corner and we seem helpless.

When Chief Olu Akinfosile and late Dr. Abiodun Ijose ran for offices, the people raised money for them. They knew these people had a track record of service and love for the people and the community. Today, who born anybody without money to venture into politics.

But I am saying it is doable with ideological political parties. I am not talking of jeunjeun platforms like Labour Party that is being used to court dissidents from PDP and APC, but a party that is truly focused and ideological. People would volunteer their houses, vehicles, time, talents, even money, and other resources to grow the party. This is the reason I don't believe Sowore is serious in his struggle. If he had followed this my recommended approach, starting from Kiribo, our community nearby where he hails from, by now, his party would be in contention for House of Reps in Irele/Okitipupa Federal Constituency.

Meanwhile, I wish Dele and the other two contests Hon Gholuga and Prince Odimayo favour before the electorates. I have great hopes for Nigeria. The rot is too much. So we must be ready to start a slow sure process to recover our country from rudderless political parties. As a social scientist, I believe that it is easier to solve a problem when you start from the parts and not from the whole.

n June 22, the German giant, Bayern Munich, unveiled Sadio Mane as one of its top signings for the coming season, thus effectively putting to rest the speculations surrounding his time in Liverpool FC, my darling club.



# PDP splits over Gboluga, Sheba, Agbo



#### ...POWER TO THE PEOPLE

he dust threw up by the emergence of the former Deputy Governor of Ondo State, Agboola Ajayi and the lawmaker representing Okitipupa/ Irele Federal Constituency, Ikengboju Gboluga as the Senatorial and House of Representatives candidates of People's Democratic Party, PDP (respectively) has refused to settle.

Agboola and Gboluga emerged as the candidates of the opposition party at a primary conducted in May. While Agboola defeated the incumbent Senator, Nicholas Tofowoma, to clinch the ticket in a keenly contested election.

Gboluga polled 36 votes to defeat Sheba who polled 30, Sheba. Reliable sources indicate that many chieftains of the party who had issues to settle with Hon Gboluga have found it difficult to accept that they have to work with the Ilutitun-born pharmacist to win the election in February. Some of Sheba's arch supporters of the former Acting Chairman of the Federal Character Commission, include; Senator Boluwaji Kunlere, Chief Eddy Olafeso, Hon Niyi Adebusoye, the several ward chairmen of the party.

At the time of filing this report, *Ikale* News can authoritatively report that prominent leaders in PDP in Ondo South Senatorial district have resolved not to support the two candidates

Some of the members of the party who pleaded for their names not to be mentioned told Ikale News that they would prefer to vote for a different person from Agbo and Gboluga

Said one of them: "Some of our leaders in this senatorial district were unhappy over the emergence of the duo. We can't work for candidates who do not respect our leaders, whose performance has been abysmal to say

the least,

Another chieftain of the party confided in our correspondent: "We can't glorify failure, Ikale, Ilaje and Apoi are too blessed to have mediocres in the National



Assembly. Imagine someone who left out party shortly after he lost at the governorship primary, he came back without following the due process and what to fly the flag of this party this will never happen".

Some of the party chiettains are not happy that Agboola only recently rejoined the PDP from the Zenith Labour Party where he was the candidate of the party in the 2020 gubernatorial election in the state and that it would be an insult to cede the ticket to him.

Ikale News investigations however reveal that the issue between the party chiefs and Gboluga/Agbo smacks personnel animosity. "There is bad blood between them and this may cost the party the senatorial and the House representatives seats in 2023. The party may not recover from it and the APC may capitalize on that now that a Yoruba is flying its presidential ticket,"a grassroots political analyst told our correspondent.

# Igbotako Denies Indigene's Involvement In Kidnapping

I gbotako, a community has debunked police report that an indigene of the town, Adeola Omoniyi were involved in serial kidnapping of children.

The alleged kidnapper who was paraded at the Ondo State Police Headquarters in Akure alongside her father, disclosed that she has been working in connection with her father, Ilesanmi, who usually pays her a sum of N30,000 for each toddler kidnapped and deposited at his place in Igbotako.

However, in a statement on Monday, the community said the parents of the alleged kidnapper are not from Igbotako but a neighboring community. The statement, signed by the Councillor representing the ancient town, Hon. Segun Olajide, added: "Our attention has been drawn to a false and misleading report that the suspected female kidnapper, Adeola Omoniyi, claimed to be from Igbotako.


" Having read the reports of the incident, we are disturbed that she mentioned Igbotako, we made our findings and it was revealed that the accused parents have no traceable lineage and connection to our town.

The statement further revealed that the parents are from a neighboring community and not Igbotako as falsely reported. We urge the general public to kindly take note," the statement said.

When contacted, Hon Olajide told Ikale News that the lady and her father are residents of Gbaragada Village and that they probably hailed from Ilutitun but migrated to the Ikale Village located in Ogun State.

He explained that the man's name is Ilesanmi Omoniyi b u t i s m o r e popularly referred to as Ijabodi.

"He had a wife but the wife had divorced him. The woman had a boy and a wife for the man and the man fostered the two as single parents on the girl travelled to Lagos in search of the Golden Fleece only to come back few months ago reportedly insane.



Hon Olajide told Ikale News that he had adequately brief the paramount ruler of Osooro, The Rebuja Oba Gbadebo Bajowa of the development who instructed him to brief the divisional police headquarters in Igbotako of the community's side.

"This has been done and we have assurance that the DPO has communicated the true even to the State Police Command in Akure," Olajide stressed.

The Police Headquarters in Akure had paraded one Adeola said to hail from Igbotako and claimed that she confessed to kidnapping children and



selling each child for N30,000 to her father for the past two years.

She allegedly told the police that her father, Ilesanmi Omoniyi, had been taking delivery of the victims and later paying her the sum of N30,000 for each operation.

"I'm a kidnapper. I kidnap little children and I always deliver them to my father in his house at Igbotako.

I was successful with the first two children I took but I was caught with the third one" she reportedly

claimed, adding that after delivering the kids to her father, he used to give her N30,000 for each operation and that she would use the money to take care of her daily needs.

When the detectives asked her what her father used the toddlers for, she allegedly claimed she did not know and that she never bothered to find out what

her father did to the toddlers after collecting the money.

He was the one that told me to always bring the children to him. I picked the first child from Ilutitun and the second from Ilowo," she said.

Recounting how she nabbed, she said;

"It was when I was taking the child away that the mother raised alarm. People gathered to beat me and I was taken to the police station before I was moved to Akure.

I have been doing the business for about two years. The first one was in 2021 and the second one this year. I always offer to help the children when they are alone they will follow me."

However, upon questioning, Adeola's father, Ilesanmi denied the crime and insisted that his daughter lied against him.

"My daughter used to stay in Lagos. She got sick and they brought her to me in Igbotako. She was stark naked when they brought her to me. I later took her to a church where the pastor said I should pay

N80,000. I sold my cassava and I paid the pastor. He later told me that she is better but few days after he called again that he could not find her as she had left the church.

"I'm the one that she used to bring the kids to. I have never given her N30,000. It was six months after she left the church, we have been looking

for her that I heard that she went to steal a child". He said. The state's police spokesperson, SP Funmi Odunlami, disclosed that the suspects will be charged to court

after the investigation is concluded.

Concerned community leaders responded swiftly by investigating the report which they later

found out was incorrect and might have been due to the mental imbalance of the lady.

The community, however, said it would give full cooperation to the police in their investigations

and has therefore formally briefed the divisional office of the police officially of its readiness to

assist it in further investigations.

# Ikale Activist And Lawyer, Dele Kuboye Emerges As "Third Force" For House Of Reps By Bolu John Folayan



## Let us have a brief about who you are please

My name is Dele Kuboye. I am from Erekiti Luwoye, Ikaleland. That means I am from Okitipupa local government area of Ondo State. I was born in the early 1970s I had my primary education in Iju Oke and Erekiti and proceeded to Community Grammar School, Igbotako. I went from there to Adekunle Ajasin University, where I studied law and graduated in 2005. I did my national youth service in Jos Pleateau State; that is after my obtaining my BL at the Nigerian Law School.

## You started law practice after NYSC?

No. I went to UK see in search of the proverbial Golden Fleece. I was there for a few years and came back 2010 to fully establish my law firm and get into some business activities. I established my law firm and set Carrington Supermarket in Akure. I am also property business.

# Good. Now let us talk political. I have always known you to be an activist. Why partisan politics now?

Well, sir, I have decided after due consultations to come into politics. Our people (Ikale) have not been properly

represented for a long time. We have not had a responsive representation in the national assembly. I think I am capable, culturally, socially and sufficiently educated to give our people good representation at the national assembly.

The irony of this political representation matter is that youths and women account for the larger number of votes. Yet, none of them ever gets in there. Why?

It is unfortunate. Most youths nowadays are interested in money. They will not do anything unless you give them money. As you rightly observed, those who are younger are not ready. The ones called "Not too young to run" and not running. They are the ones campaigning for the older generation. That is why we are stepping into th foray. With a lot of advocacy, we will change the situation.

## You are vying for the House of Representatives under which party?

We have been part of the All Progresive Congress (APC) and the People's Democratic Party (PDP) for quite a number of years. What do we have to show for it? No electricity for over 15 years consecutively.

No development. So, running under those parties will not enhance what we want to achieve. I am coming out under the platform of the Young People's Party (YPP).

What they will tell Peter Obi is what tey will tell you: No structure on ground I can proudly tell you that we have structures. Our exco is fully in place in the 23 works making Irele/Okitipupa Federal Constituency. That is what we call ward structure. By the end of July, we will be

fully in place in the nooks and crannies of the area.

To cover the two local governments, we need about 400 units and we are almost there. Many prominent persons in both APC and PDP are coming to join us and we have been welcoming them. They are people of solid integrity.

Are you sure you can match these older or bigger parties naira-for-naira? Because in the last primaries, what my eyes saw in terms of naira distribution...money matters o. Where are you going to get money Dele?

Well sir, I am fully aware of the role of money in politics or elections. The day I declared to run for this office, we started spending money. For example, we obtained the nomination and expression of interest with money. We have been going round and that costs money. But to answer your question directly, we are not going to be able to match them money-formoney. But we will match and surpass them in terms of integrity, intellect, advocacy for advocacy. We know that by now Ikale people know the category that they belong in Ondo State. Yes, we need money but it is not going to be all about money.

They did that to an extent in the last election in Ekiti. Today, our people are frustrated. You see the frustration in them. I think they are going to take advantage of this situation and vote the right person. People are now more conscious of the fact that they are being ripped up. We have stepped up advocacy in this regard. We are deploying the social media and we are making impact. By the grace of God the money that would be need would be provided.

Lawyer, we hear from reliable sources that you are a Third Force; a third alternative. We hear that people who were not happy about the last primaries in APC and PDP pushed you forward as a third force. Can you confirm or deny that?

I can confirm that many people felt aggrieved as you said. It is normal to have that in a democracy. So if that benefits me fine. But it is not as if people were not disgruntled in the other parties, I would not be contesting. I would say that the development there is boosting my candidacy. I thank those who look up to me in that regard. We need their experience. For now, people are rooting for Dele Kuboye in person.

It seems I am even more popular than the party. But in due course, the party will take its due position.

More candidates will emerge and that will make the party more popular than all of us.

## What will be your priorities if elected? What will you do differently?

I will first use my position to unite our people. We have too many divisions amongst our people. We have never been this divided. We will put in inclusive programmes. Representing our people at the National Assembly is a national duty, as you know.

Third, agriculture and the environment. We can do quite a number of things also working with the private sector. It is not all about government. I will ensure that we lobby to put our roads in order. Well, you can say how do I do this among almost 300 legislators but I don't mind to prostrate to get things. We differ in our approach. That is why we should vote in there someone who is humble and is ready to beg if need be to serve. It is call to service.

Lawyer, thank you for this candid interview. We hope to be able to speak with you again before the elections next year, *Ki Olorun so gbogbo wa*.

# Tofowomo tackles Agboola, alleges he is using false academic records - "It is pure blackmail" says Agbo



Ondo South senatorial district, Nicholas Tofowomo, has dragged a former Deputy Governor of Ondo State, Agboola Ajayi to a Federal High Court sitting in Akure seeking his disqualification as the 2023 Senatorial candidate of the People's Democratic Party (PDP) for the district over his alleged controversial academic records.

Hon. Alfred Agboola Ajayi is joined in the suit as first defendant, Peoples' Democratic Party (PDP) and Independent National Electoral Commission (INEC) are second and third Defendants respectively.

In a suit number: FHC/CS/AK/ 83 /2022 filed on Tuesday July 5, 2022, Senator Tofowomo who came second in the PDP senatorial primary, said Agboola did not meet the constitutional requirements for contesting the 2023 general election

as contained in the interpretation and application of Section 66(1)(i) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) and Section 29(5) & (6) of the Electoral Act, 2022 as well as other relevant laws.

Tofowomo through his lawyer, Mr Femi Emodamori, claimed that the court should determine if together with the totality of the facts before the Court, the 1st Defendant (Agboola) did not present false information and/or forged certificate(s) in his INEC Form EC9 and the other documents attached thereto which he submitted to the 3rd Defendant (INEC) as the candidate of the 2nd Defendant for Ondo South Senatorial District in the 2023 General Election.

"I verily believe that the 1st Defendant (Agboola) lied and/or swore to a false information when he stated in Exhibit FEE4 (the Affidavit For Correction of Date of Birth which he submitted to the 3rd Defendant) that he was issued the 2004 WASSC (Exhibit FEE3) No. NGWASSCS 5529745 and claimed "that in the said Certificate my date of birth was mistakenly printed as December 8, 1980 instead of 24th September 1968".

The Senator also stated that "Whether, having regard to Section 29 (6) of the Electoral Act, 2022, the 1st Defendant (Agboola) should be disqualified as the candidate of the 2nd Defendant (PDP) for Ondo South Senatorial District in the 2023 General Election.

He urged the court, "A DECLARATION that having regard to S.66(1)(i) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended), S.29(5) of the Electoral Act, 2022 and judicial authorities which include the Supreme Court decisions in MODIBBO V USMAN (2020) 3 NWLR (PT. 1712) 470 and PDP V. DEGI-EREMIENYO (2021) 9 NWLR (PT. 1781) 274.

"AN ORDER of this Honourable Court disqualifying the 1st Defendant as the candidate of the 2nd Defendant for Ondo South Senatorial District in the 2023 General Elections.

"AN ORDER of this Honourable Court declaring the Plaintiff, having scored the 2nd highest number of votes in the 2nd Defendant's Primary Election for Ondo South Senatorial District held on 23rd May, 2023, as the candidate of the 2nd Defendant for the said Senatorial District in the 2023 General Elections.

"An order of this Honourable Court directing the 2nd and 3rd Defendants to substitute the Plaintiff for the 1st Defendant as the candidate of the 2nd

#### July, 2022.

Defendant for Ondo South Senatorial District in the 2023 General Elections," Tofowomo prayed the court.

In a swift reaction, supporters of Agboola Ajayi fired back at the incumbent senator, condemning his move as that done by someone who could not take defeat in good faith.

A prominent Ilaje politician, Hon Banji Okunomo took to the social media to lambast the senator, insisting that he should have taken the primaries as an act of God and respect the wishes of party delegates who voted in the elections.

According to Okunomo, many Ikale,

Ilaje and Apoi rallied round Tofowomo when he was seeking to go to the senate when his own people did not support him. He now wondered why he could not reciprocate same gesture when the same people now wanted another person to represent the area.

He pointed out that a competent court of law had decided on the issue Agboola's certificates and that in law such a matter would not be listened to by any court again.

"The matter is making noise over is Res Judicata. It means the matter had been decided to finality and this kind of issue would only split the party and make room for the opposition," he

stated.

A PDP chieftain in Irele also faulted the step taken by the Senator: "Even if Tofowomo wins at the high court, Agbo will appeal and we will be on it until the elections.

That is one thing. The second thing is that after winning Agbo or after winning Tofowomo, will supporters of the two giants ever come together to work for PDP success in the elections? I don't think so. I think the Senator is paving way for Jimoh Ibrahim's victory through his action. You don't bomb the bridge after crossing the river. You never can tell"



struggle: You struggle to be able to fit into life and succeed. You may have to struggle for position, power, authority and influence and some time for survival! Many attain greatness through circumstances of one's birth and sometime through hard work. All the above illustrates the life of Oba Gbadebo Bajowa, Lubokun IV, Rebuja of Osooro, He belongs to the group of people who rose to success via circumstances surrounding his birth and by dint of hardwork.

He was born during the burial ceremony of Lage Oba Danebi (his mother's father), at Ubu and was therefore named "Gbadebo". No wonder then he later became the Rebuja of Osooro. He literally brought back the crown, as his name implies.

Alayeluwa Oba Bajowa, was born to a Christian home and Lubokun Royal family at Igbotako in the Okitipupa Local Government Area of Ondo State of Late Chief Ezekiel Akinmoladun Odunwo Bajowa, a son of Akingbagbohun, the son of Jomos Oyetoyo. His mother, Mrs. Bolatiwa Didunyemi Bajowa was born to Olugbodo Royal family as a Princess by late Oba Danebi, the Onipe of Ubu in Ogun State waterside. In quest for further education, Oba,, Gbadebo Bajowa, went to Lagos on the 6th of January 1957 with his late uncle,


Zebulon Ujobire Bajowa, He immediately, on getting to Lagos, started evening lesson to pass his GCE ordinary level. The thirst for further education was not possible because his parents were couldn't afford his Secondary Education. Upon this background Oba Bajowa felt that without money he could stilt rise above his level. He went to Etti Institute of Stenography as young as he was. His determination to succeed in life led him through to obtain certificate in royal society of arts in secretary studies at an advanced stage.

He also obtained certificates in secretarial services, office layout and productivity from the Nigerian Institute of Supervisory Management. Oba Bajowa's high commitment to the Christian faith is a legacy he inherited from his parents reflects as he is an active member of various Christian organizations including Cherubim and Seraphim movement, during his early years. Young Prince Gbadebo Bajowa loved singing, and playing football, His late father was a professional tailor, a famer and an occasional palm wine taper as well as a community leader who was highly respected in the entire Osooro Kingdom.

Prince Bajowa during the days of his father especially when he was still a teenager had no time to play around as such. This was due to his desire to

accomplish a lot in life to be able to stand on his own after sometime. His late father also did a lot to encourage him as a youth, for instance, Prince Gbadebo was not allowed to go to the farm. He spent most of his leisure hours under the tutelage of his brother, Prince Oluyemi Omokuwajo Bajowa who usually engaged him un extra academic studies as his later father would not like to pamper him by allowing him to play around.

During the later hours of the day, especially during moonlight, the young prince enjoyed his listening to folklore and tales from the elders together with his mates. Late Pa Ezekiel Akinmoladun Odunwo Bajowa, the father of Oba Gbadebo Bajowa, was not discriminative during his lifetime. At festival periods like Christmas, Easter and harvesting time, he usually bought new clothes for all his children. His mother Alice Bolatiwa Duduyemi Bajowa a farmer was a greater lover of children; she usually ensured that meals were always ready at required times for the children. She also liked neat environment hence she always made sure that her children appeared in neat clothes. His mother was known for always praying for her children to succeed in life and to survive her, as most Ikale women were fond of. In the slightest misdeed, his mother would not curse any of her children but rather she would correct them in love She was such a loving and caring



mother.

After his course as a secretary in Lagos, Prince Gbadebo started his working career with CMS Bookshop now CSS as secretary. He resigned his appointment and joined Marina Agencies now United Nigerian Insurance Company. From there he proceeded to the following organizations: Eagle Star Insurance. LANGOK KINGSONS Nigeria Ltd, Tower Aluminum Nigeria Ltd. Ikeja, Intercotra (Loyds Depo Apapa,) Standard Bank Nigerian Ltd, (Now First Bank), Chief Obafemi Awolowo Law Firm, Nigerian External

Communications Limited (laer NITEL) from where he resigned his appointment to become the Twelfth Rebuja of Osooroland in 1977.

During the above periods, he was a "darling" to all his employers who would not want him to leave them to take up appointment elsewhere, Considering his high level of performance, as an efficient Secretary, he used to be a very dutiful officer who can be relied upon for very effective work without supervision. All of these attributes helped him later as an Oba. He is very reliable and of sound and

balanced judgment. As he was a great asset to all his employers, in whom much trust can be put, he became a great asset to the community and entire Ikaleland.

As a resourceful and intelligent secretary, for instance, he used to close for the day's work when there was no more to be done for the day. That is why till today, no one can find Oba Gbadebo idle. He is always busy with one thing or the other.

Oba Bajowa's life ambition was to become a verbatim reporter in the House of Representatives having obtained the necessary qualification. His inspiration to become a verbatim reporter began the very day he went to the house of parliament to see his brother, major General Oluyemi Bajowa (rtd) while working there as a clerk, There, Oba bajowa saw verbatism reporters recording the proceedings of the house at a very high speed' there and then Oba Bajowa derived is desire to be one of them in the future. Today, even if Oba bajowa did not become a verbatism reporter as was anticipated, he rose to the pinnacle of his carrier as a secretary before the nature beckoned to him to become an Oba.

Oba Bajowa's many honours include:

1. Notable citizen of Nigeria (NCN) 1987 by the Oluyole institution of management and vocational studies

- 2. Justice of peace (JP) 1988 By the Ondo State Government
- 3. Institutes Highest ward of honorary fellowship (FIAMN) by the certified and distinguished traditional administrator
- 4. Institute highest award of honorary fellowship (CDTA) by the Nigerian certified and distinguished traditional administrator
- 5. Honourable fellowship of the Nigerians Society of Philanthropist (FSNP) INC by the Nigerian society of philanthropist.
- 6. Honourable fellowship of the Nigerians Society at Philanthropist (APPEL) By the Africa part of peace and exceptional leadership
- 7. Oba Bajowa was president at the defunct Ikale Local Government and later Okitipupa Local Government
- 8. He is the Patron, National Students Union as well as President and/or Chairman of man Clubs and Association all over the country
- 9. He was Pro Chancellor of Adekunle Ajasin University where he influenced so many trail-blazing achievements.

Having mounted the throne at the age of 35, Prince Ghaticho Bajowa who succeeded Oba D.I. Juba was the youngest Rebuja ever to ascend the throne of the legendary Osooro

Kingdom (comprising of Ilutitun, Iju Odo, Igbotako, Erekiti, Iju Oke down to its adjunct settlements up to Ajebandele and parts of Ogun State). Following his unanimous nomination as the New Rebuja, the King Makers forwarded his name to the Ondo State Government and approval of his appointment was made on the 22" of July 1977 which was published in the Ondo State of Nigeria Official Gazette, Notice no 189 on 20th October 1977. The ceremonial and traditional installation of Gbadebo Bajowa as the New Rebuja was glorious. It was the first time the Jomo Yetowo Ruling house would produce a candidate and the entire community embraced his choice.

The journey has not been an easy one for the Rebuja who was caught off at the prime of his youth to come and live in the village. But November 1977 would remain indelible in the history of Igbotako and Osooro. The entire Osooro came to together for the installation. Comfort Omoge (rising star at the time) and Juju superstar, King Sunny Ade were at the bandstands. Igbotako was totally agog. All women were clad in white dress and witnesses say there has not been a day like that since then in the historic town.

Looking back, Oba Gbadebo Bajowa gives all the glory to God Almighty. He described his journey of life as reflection of destiny and that he is full gratitude to God. An orator and great writer, Oba Gbadebo loves peace and always embraces anything that would unite Osooro Kingdom.

# Osooro Kingdom under Oba Gbadebo Bajowa: Legacies of peace and unity

he greatest achievement of any political leader whether traditional, democratic or military is to attain peace for the community. Traditional rulers whose tenure were marked with crisis and insecurity have no good portions in the record of history of such community. Thus, analysts believe that the greatest achievement of Oba Bajowa is "peace and unity"

Many people take it for granted that there is absolute love in Osooro Kingdom today just by coincidence. It is not so. It is the product of silent works and lobbies for individual citizens and towns to attain this and the arrowhead has been Oba Bajowa. A very humble king, Oba Gbadebo would do anything possible to have peace. Even when hamlets and villages under did things that should irk him as the paramount ruler, Oba Gbadebo would use maturity and wisdom to tackle such issues and usually he would have the last laugh, although initially his subjects sometimes think he was slow to act. Rather, he is a very methodic person.

Oba Gbadebo used his profession as a writer to maximum effect. to develop. He has written thousands of reference letters many of which fetched his subjects admissions, employments, promotions, etc At other times, he would jump into his car at his own cost to ensure his reference letters get through. No wonder, Osooro indigenes are soaring high in various professions across the nation. In terms of amenities,

he contributed to the establishment of Comprehensive Health Centres (later General Hospital) in Igbotako, Iju Odo and Ilutitun, apart from various other maternity centres. Electricity projects were also commissioned in Igbotako, Iju Odo, Erekiti, Iju Oke and Omotoso during his reign. Other various progressive achievements were: reinstatement of Igbotako Police Station which is now a Divisional Police Station (attained in collaboration with DCP Bode Ojajuni), Bishops Court in Ilutitun, Community banks, Town Halls, revival of Chief Magistrate Courts (in collaboration with the Igbotako Development Forum, upgrading of Igbotako Post Office to a departmental status, construction of churches and renovation of the town's mosque, and the reconstruction of of the Logholoma Water Scheme.

Oba Bajowa has been dedicated to improving the living conditions of his people as much as humanly possible. Despite his own meager resources on mounting the throne and his own personal responsibilities, he is always at home to help people.


The political life of the people of Osooro has witnessed what could be described as tremendous transformation during his 30 years on the throne. He encouraged the participation of Osooro indigenes in politics through motivation and unflinching support, knowing very well that when indigenes occupy political offices, they would certainly use their

political influence to bring development to the communities. Today, Osooro is one of the major centres of political activities and calculations in Ondo State. The Governor of Ondo State currently, is a subject of the monarch and through his spadework and activities of other indigenes, there is no doubt that some day, Osooro will produce the President of Nigeria. For his contributions to the development of the community, Oba Bajowa has carted home various awards, including Justice of Peace (1988), Fellowship Award of the Nigerian Society of Philanthropists, Highest Award of the Institute of Administrative Management of Nigeria. He is patron of so many clubs and societies including the National Students Union. Here is 45 *Kaaaaaaabi-ye-si* and gbosas for a man of great intellect and an accomplished orator; a man of peace, a lover of unity of progress, indeed a man who has brought succor and development to his people.


